### Meeting Minutes

The Petersburg City Council met in a meeting Monday, April 14, 2020 @ 6:30pm. at Petersburg Community Center, 1900 Ave E. 2020.04.14.01 Announcements: Next regular meeting will be May 11, 2020.

2020.04.14.02 This item was moved to the end of the council meeting.

2020.04.14.05 Consent Agenda: Councilman Porter moved to approve consent agenda. Councilman Mathison seconded the motion. Motion Carried 4-0.

2020.04.14.07 Discussion/Action concerning complaints against SPWS. Nick LaChico came in and went over with the council that hopefully within 6 months the calls and the complaints will slow down. They have replaced residential with illegal ones throughout the city. He clarified with the council that Monday and Tuesdays they do all the businesses and then half the city on Monday and the other half on Thursday. They have taken care of all the fines with complaints. They are also replacing fines with citations to apprehend future complaints.

Kim has stated his opinion about how much it is needed to have these members of our community. Councilman Porter moved to approve. Councilman Campus seconded the motion and the motion carried 4-0.

Auditors are going to walk around from one attorney to move forward with completing the other walk. Councilman Mathison made a motion to approve the audit be looked over by legal counsel. Councilman Sims seconded the motion and the motion carried 4-0.
